

Introducing

(VCA's Information System for Type Approval)

VISTA is an electronic technical standards library which contains of all the automotive EU Directives & Regulations and UN Regulations required for Type Approval. You can subscribe to all VISTA subjects; one or more whole frameworks, Car Truck and Bus, Motorcycle or Tractor; or just for a single subject if you are only involved with specific vehicle components, such as brakes or lighting.

Consolidated versions of all EU Directives & Regulations and UN Regulations (where amendments exist) are provided. Also included are all non-confidential VCA Technical Interpretations, with links between these and the individual relevant standards.

Access

VISTA is available in two formats:

- **Web Access** – updated at least weekly & needing no additional software as access is via your web browser. It is designed for MS Internet Explorer 8. It will work with later versions and other browsers, but the view may be different.
- **Windows Version with free web access.** A Microsoft Windows version of VISTA can either be supplied monthly as an ISO file which is distributed to users by ShareFile; or bi-monthly via DVDs which we would post to you. This service comes with free web access. It can be quicker than working online and is ideal if you need access to VISTA anywhere where web access cannot be guaranteed. This version is supplied with its own self-contained software and is available either 'standalone', for installing in individual PCs or Laptops; or 'network' for installing on servers, ideal if you want access for a whole office or department. PLEASE NOTE THIS SOFTWARE CAN ONLY BE INSTALLED ON A WINDOWS DEVICE. IT WILL NOT WORK ON ANDROID, IOS OR OTHER OPERATING SYSTEMS.

Three types of licence are available:

- **Single to Five Users** – Only for the number of users specified. Charges vary according to the number of users required.
- **One Site** – Any number of users working for or on behalf of the organisation or department subscribing to VISTA and based at the same geographical site.
- **Full Corporate Licence** - any number of users working for or on behalf of the organisation or department subscribing to VISTA and based anywhere in the world.

Alternatively non-UK EU based customers need to supply their VAT/IVA No to confirm that they are paying the tax in their own country. **The UK VAT rates quoted are 20%, correct when this price list was created & may be subject to change**

Plan ahead with Stat

LegStat is an online database showing the status of type approval legislation (there is no offline option for this service). LegStat tells you what automotive proposals and legislation changes are in the pipeline, so you can plan ahead. Subscribers can gain online access to documents in the database. In addition, the system provides users with email notification of new documents and into force dates that apply to your business needs.

Access is via an email address & password. For additional users you need to supply additional email addresses, these can be generic i.e. [homologation@....](mailto:homologation@...)

Because you can log in and chose to be informed of as many, or as few subjects as you want, LegStat is supplied at a flat annual subscription rate of £350.00 + VAT for one email address. There is an additional annual charge of £50.00 + VAT per additional email address. The VAT rates quoted are 20%, correct when this price list was created & may be subject to change
