Notes

VCA will only hold personal information that it has received as part of a request in respect of one of the services it offers, or otherwise has been sent a request for information. VCA does not collect citizen information or hold it on behalf of other areas of government e.g. DVLA, DVSA, DfT etc.

Receiving a response

You should normally expect to receive a response to this request within one calendar month.

VCA will:

- Tell you what information about you that it holds;
- Tell you how you can access your personal data; provide a digest of that data or copies of what is held;
- Provide other supplementary information about the data as required.

Your rights also extend to the following activities:

- · the right to request rectification;
- the right to request erasure;
- the right to restrict processing;
- the right to data portability;
- the right to object to the way your data is being processed; and
- the right not to be subject to automated decision-making including profiling.

Verifying your identity
