## Workshop

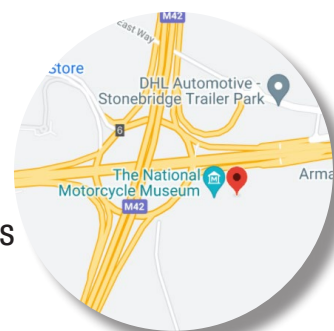
