Conformity of Production ensures that each vehicle,
СоР	Conformity of Production	system, component and technical separate unit, part or equipment produced is in conformity with the approved type.
DVSA	Driver and Vehicle Standards Agency	DVSA is an executive agency of the Department for Transport. They are responsible for driving tests, MOT tests, carrying out tests to make sure lorries and buses are safe to drive, carrying out roadside checks on drivers and vehicles, and monitoring vehicle recalls.
EU	European Union	The European Union (EU) is an economic and political union between 27 European countries.
GB	Great Britain	Collective term for England, Scotland and Wales.
IATF	International Automotive Task Force	The International Automotive Task Force (IATF) is a group of automotive manufacturers which aims at providing improved quality products to automotive customers worldwide.
ISO	International Organization for Standardization	The International Organization for Standardization is an international standard-setting body composed of representatives from various national standards organizations. The organization develops and publishes worldwide technical, industrial and commercial standards.
L	Motorcycle category of vehicle	Motorcycles from scooters to quadracycles.
М	Passenger vehicle category of vehicle	Passenger vehicles including cars, minibuses and large busses.
Ν	Commercial vehicle category of vehicle	Commercial vehicles from small vans to large lorries.
NC	Non-Conformance	Non-conformance is the failure to meet one or more requirements.
NRMM	Non-Road Mobile Machinery	Non-Road Mobile Machinery is a mobile machine, transportable industrial equipment or vehicle with or without body work, not intended for the use of passenger or goods-transport on the road, in which an internal combustion engine is installed. In the presentations, reference is to these engines not the machinery itself.

RDW	Rijks Dienst Wegverkeer	Dutch Vehicle Type Approval Authority performing tasks on behalf of the Ministry of Infrastructure and the Environment. Repair and Maintenance Information means all
RMI	Repair and Maintenance Information	information required for diagnosis, servicing, inspection, periodic monitoring, repair, re- programming or re- initialising or the remote diagnostic support of the vehicle and which the manufacturers provide for their authorised dealers and repairers, including all subsequent amendments and supplements to such information. This information includes all information required for fitting parts or equipment onto vehicles.
